How do I get selected?

Families who have the lowest income and have been on the waitlist longest are served first, unless a referral is received from Child Protective Services for a child who is at risk of abuse or neglect. At risk families are always served first.

How long is the wait?

The wait varies. Unfortunately it is not possible to give you an approximate time. Enrollments are only made when funding becomes available or there is an opening in a program. Placement on the wait list is not a guarantee of services.

What happens next?

You will receive a confirmation in the mail within 2 weeks of submitting a completed application. Submit your application to: 1135 Lincoln Street, Red Bluff, CA 96080

Update your application every 6 months & anytime there is a change in your information.

Tehama County Department of Education FCCHEN (0-13yrs)

The Family Child Care Home Education Network is designed to provide full or partial payment for child care for eligible families. In order to be eligible, the child must be under 13 years of age. Enrollment is based on eligibility and need as openings occur. Priority for enrollment is defined by the State Department of Education. Parent/guardians must choose one of the approved and participating FCCHEN licensed family child care homes.
