#### 4. Social Services/Child Protective Services Presentation

Veronica shared that she met with the Director and Supervisor of Child Protective Services on Monday, January 8, 2018. Administrators at Tehama County Social Services and Child Protective Services met with Veronica to better understand the role of SELPAs. Veronica relayed to them that the SELPA does not have any students, but provides guidance and technical assistance to districts on many different areas. She provided information on who agency partners should contact if they have concerns related to specific students. She volunteered to create a contact list for Social Services. Social Services/CPS administrators indicated a desire to partner and invite LEAs/Districts to their CFTs and placement meetings more often and also engaging in prevention prior to out of county placements.

## 5. Licensed Children's Institute (LCI) Funds

Veronica reminded the committee that the Performance Indicator Review is due on January 31, 2018 and indicated she has met with most districts and has appointments scheduled for those remaining.

Veronica summarized important factors in the Governor's budget related to special education. Areas to note were projected grants towards recruiting special education teachers and compliance work, aligning with County Office of Education's differentiated assistance.
