## **MEETING MEETINGS**

Veronica reported out the final revenue received for Out of Home Care funds. There was a significant decrease in this revenue as the bed count was taken from December 1, 2016 and a group home that generated revenue in our county closed in November of 2016. The amount of expenditures exceeds the revenue. There will be a shared cost amongst the districts who use the funds for the approved non-public school placements. Veronica reported that she and Jackie Douglas are researching a shared cost formula at the request of the committee and will bring simulations to a future meeting in the fall. Veronica also reported that a small group of SELPA Directors are working together to propose a new funding formula to the state.

### 7. CDE Annual Determination Compliance Letters (2016-2017)

Information

Veronica provided information on the different types of compliance reviews. Districts/LEAs recently received notice for reviews related to disproportionality and performance indicator review. There was a request from the council to provide input to CDE on the confusion of multiple reviews at one time.

### 8. Director's Report

Information

Veronica reported on the following:

Allocation Model: This is the first year of full implementation. We will be monitoring the allocation and bill back implantation.

Staff Shortages: Countywide, we are experiencing a shortage in Speech/Language Pathologists and are having to utilize an online/remote platform for services. SELPA is still short three SLPs and have been working with districts who are short in that area. We are also short in a Deaf/Hard of Hearing Specialist Teacher, as an employee resigned at the end of last year. We have not been able to fill this position and we are looking at creative ways to ensure services are being met in this area.

Local Plan: Veronica will begin bringing sections of the Local Plan revisions this year as we embark on approving the local plan at each individual school board.

Upcoming Professional Development: Alternative Dispute Resolution training for administrators, service providers, and parents will be offered this year.

Inclusive Sports: Jody Johnson will be implementing an inclusive sports program this year. She was awarded a grant to obtain funds to hire some adapted physical education teacher time to allow her time to work on inclusive sports with each district.
