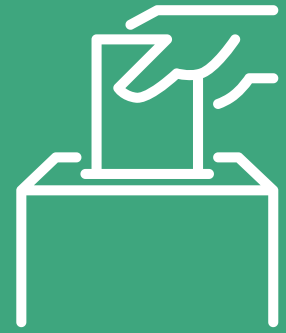

## Flavored Tobacco Products Ban Referendum (Proposition 31)

This year, Californians have the opportunity to vote YES or NO on banning tobacco flavor products; excluding hookah tobacco, loose leaf tobacco, and premium cigars. During a recent survey in Tehama County, almost 80% of students totally agree or agree that tobacco flavored products are more attractive for kids and teens.

In California, 96% of high school youth who use tobacco products, started with tobacco flavor; i.e. strawberry, chocolate, or donut.

A YES vote will uphold SB 793 and ban the sale of tobacco products.

A NO vote will repeal SB 793 and the sale of tobacco flavor will be legal in California.
